PRISCILLA ANN WOODSIDE, her heirs and assigns, forever:

ALL the right, title, and interest of the James Preston Woodside Estate, the same being an undivided one-half (1/2) interest, in fee simple with Grantor herein, in and too: 75-530-1-4 Note

ALL that piece, parcel or tract of land lying, being and situate in the County and State aforesaid, Fairview Township, containing two hundred thirty-one (231) acres, more or less, according to a plat and survey made by W. J. Riddle, Surveyor, of the Maria Harrison property, July 16, 1934, and having according to said plat the following courses and distances, to-wit; Beginning at a sycamore tree on line of land now or formerly of Alice Durant, and running thence S. 1 W. 429 feet to a red oak; thence S. 41-30 E. 3581 feet to a point on the South side of the Jenkins Bridge Road; thence N. 73-30 E. 132 feet to a stone; thence continuing along said road N. 81-10 E. 784 feet to a point; thence N. 89-10 E. 1266 feet to a point in center of said road, Alvin Foster land; thence with the Alvin Foster line N. 5-43 W. 1955 feet to a point; thence N. 59-45 W. 2855 feet to a Willow on the line of land formerly belonging to John Harrison; thence N. 60 W. 262 feet to a point; thence S 4 W. 390 feet to a point; thence S. 43 W. 648 feet to a point; thence N. 73-30 W. 452 feet to a point in or near creek; thence S. 83 W. 450 feet to a point, the beginning corner, and bounded by lands, now or formerly, of McPherson, Jenkins Bridge Road, other lands of the Grantor, lands formerly belonging to John Harrison, Alice Durant, Alvin Foster and others, less however, those two lots or plots of land containing .91 acres and 1.29 acres previously conveyed to Priscilla D.
