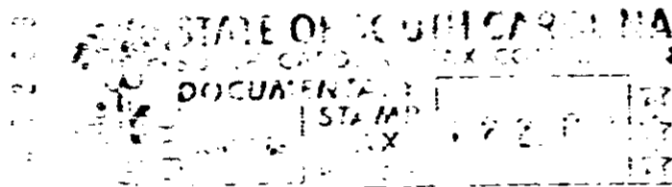
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THOMAS D. DENNISON and MARIANNE R. DENNISON, their heirs and assigns:

ALL that certain piece, parcel, or lot of land, situate, lying and being on the south side of East Tallulah Drive, Greenville City and County, South Carolina, being shown and designated as the eastern 50 feet of Lot 15 and the western 25 feet of Lot 17 on a Plat of D. T. SMITH PROPERTY recorded in the RMC Office for Greenville County in Plat Book F, at Page 108, and having, according to said Plat, the following metes and bounds:

BEGINNING at a stake on the south side of East Tallulah Drive, said stake being 250 feet east of the southeast corner of the intersection of Smith Street (now known as Penn Street), and East Tallulah Drive, and running thence with the south side of East Tallulah Drive, N 64-20 E, 75 feet to an iron pin; thence S 25-40 E, 200 feet to an iron pin; thence S 64-20 W, 75 feet to an iron pin; thence N 25-40 W, 200 feet to an iron pin on the East side of East Tallulah Drive, the point of beginning.

This conveyance is subject to all restrictions, set back lines, roadways, zoning ordinances, easements and rights of way, if any, affecting the above property.
