3. The property referred to by this agreement is described as follows:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, at the intersection of Pleasant Drive and Leona Avenue, being shown and designated as Lot No. 7, on plat of Property of H.
