ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, near Travelers Rest, being shown as 2.0 acres on plat entitled "Property of Woodrow W. Waldrop and Dora M. Waldrop" prepared by W. R. Williams, Jr., Surveyor, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Westridge Road thence S. 87 - 53 W., 266.8 feet to an iron pin; thence N. 2 - 07 W., 330 feet to an iron pin on the southern side of Westridge Court; thence N. 87 - 53 E., 241.8 feet to an iron pin; thence S. 47 - 07 E., 33.4 feet to an iron pin; thence S. 2 - 07 E., 305 feet to an iron pin being the point of beginning.

RESTRICTION:

1. Dwelling must be set back a minimum of 35 ft. From edge of Street. (This amounts to 60 ft. from centerline of Street)
2. Only one single family residence allowed on this tract. Minimum house size 1,400 square feet living area.
3. Single wide mobile home not allowed. Double wide allowed on permanent brick or block foundation, 24 inches minimum ground clearance at lowest point required. Minimum double wide trailer size 24 feet x 55 feet.
4. Temporary single wide mobile home allowed during construction of house. This mobile home can only be set up after foundation for permanent house is constructed. A maximum of one year is allowed for the temporary mobile home.
