the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto GORDON E. MANN

ALL that piece, parcel or lot of land situate, lying and being at the south-eastern corner of the intersection of Cedar Lane Road (S.C. Hwy. 183) and Marion Road near the City of Greenville, County of Greenville, State of South Carolina, being shown as the westerly portion of a 2.78 acre tract shown on a plat prepared by Piedmont Engineering Service dated May 1957, entitled "Property of J. K. Stevens & Co., Inc., Monaghan Plant, Greenville, S. C." and having according to a plat prepared by Dalton & Neves, dated April 1958, entitled "Property of Henry M. Lee," recorded in the RMC Office for Greenville County in Plat Book GG at page 167 the following metes and bounds:

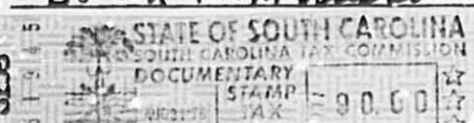
