- 2.33 Access. There shall be no access by motor vehicle from any Numbered Lot as shown on the Plat on the perimeter of the property thereon shown, except to and from designated streets and roads located exclusively within the boundary or perimeter lines of Fox Ridge as shown on the Plat.
- 2.34 Rubbish Removal. The owner of each Numbered Lot, improved or unimproved, shall keep the same free of tall grass, undergrowth, dead trees, dangerous and dead tree limbs, weeds, trash, and rubbish, which Numbered Lot shall at all times be maintained in such a manner as to prevent the same from becoming unsightly, unsanitary or a hazard to health and in a neat and attractive condition. In the event the owner of any Numbered Lot fails to comply with the terms of this Paragraph, the Developer and/or Homeowners Association shall have the right (but not the obligation) to go upon such Numbered Lot and to cut and remove tall grass, undergrowth, weeds, rubbish and any other unsightly or undesirable things and objects therefrom, and to do all other things and perform and furnish any labor necessary or desirable in its judgment to maintain the Numbered Lot in a neat and attractive condition, all at the expense of the owner of such Numbered Lot, which expense shall become payable by the owner to the Developer and/or Homeowners Association on demand, and if not paid on demand by a part of the annual assessments hereinafter provided in Article VI to which such Numbered Lot is subject. Neither the Developer nor the Homeowners Association, as the case may be, nor any of its agents, employeed or contractors shall be liable for any damages to any person which may result from the exercise of any of the rights conferred upon them as set forth in this Paragraph.
- 2.35 <u>Mail boxes</u>. The location, design, type of construction and color of free standing mail boxes shall conform with the standards established by the Developer, its successors and assigns. No mail boxes shall be fabricated, placed or altered in any way without prior written approval from the Developer, its successors and assigns.
- 2.36 Garages. Each residence erected on a Numbered Lot shall have and maintain a garage adequate in size to accommodate at least two (2) automobiles. Each garage shall be either directly attached to the main residence or connected to the main residence with a covered porch or passageway. All garages shall be enclosed with solid walls on three (3) sides and have a door which fully covers the open side.

ARTICLE III

RECREATIONAL ABUTTING PROPERTY

The following additional covenants and restrictions are hereby made applicable to any portion of the Residential Area containing Numbered Lots which adjoin the Recreational Area designated on the Plat as the Recreational Area, to-wit:

3.1 Recreational Areas. Except as specifically provided to the contrary in Paragraph 3.2, hereinafter, the area designated as the Recreational Areas on the recorded Plat and any amenities contained exclusively in the Recreational Area, shall remain privately owned and the sole and exclusive property of the Developer, its successors and assigns. No structure of any kind shall be erected, placed or permitted to remain over, into or upon any portion of the Recreational Area, or any stream contained exclusively herein, unless placed thereon by the Developer, its successors and assigns.
