in consideration of **Fourteen Thousand Five Hundred and No/100 (\$14,500.00)----** Dollars,

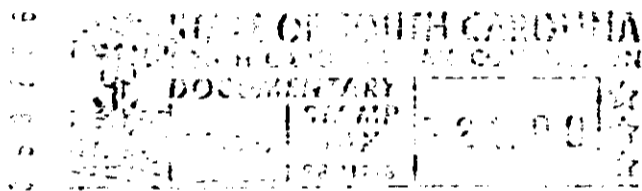
