release unto ARTISTIC BUILDERS, INC., its successors and assigns forever:

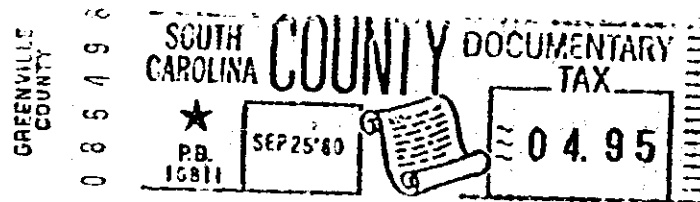
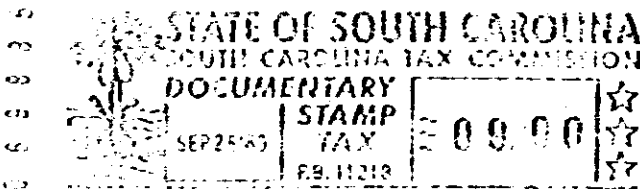
ALL that certain piece, parcel or lot of land situate, lying and being in
