CHARLES N. MORRONE AND VALERIE A. MORRONE, their heirs and assigns forever;

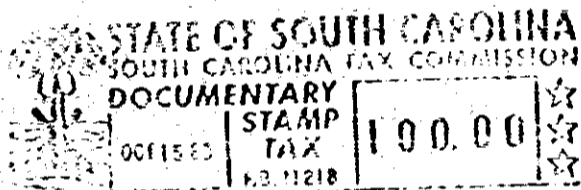
