ALL that certain piece, parcel or lot of land situate, lying and being at the northern intersection of Brooks Avenue and S. C. Highway #253 (a new road) in Greenville County, State of South Carolina and described generally as follows:

Highway #253 and running thence along the center line of Brooks Avenue north-westerly approximately 160 feet to the center of a bridge over Langston Creek; running thence along the center of said creek as the line in a northeasterly direction 10 feet, more or less, to a point; thence leaving the creek in an easterly direction approximately 168 feet to the northern side of S.
