This is the same property inherited by the above Grantors arising out of the intestate death of William R. Cameron who died on October 25, 1976. William R. Cameron acquired an interest in the subject property through the Last Will and Testament of his mother Pearle Steadman Cameron which can be found in Apartment 1384, File 22 in the office of the Probate Court for Greenville County.

This was the same property conveyed to Pearl M. Cameron, also known as Pearle Steadman Cameron, from the City Council of Greenville by way of deed dated March 29, 1932 and recorded in the R. M. C. Office for Greenville County on April 13, 1932 in Volume 153 at Page 67.
