Office for Greenville County in Plat Book 7-0 at Page 78, the following metes and bounds, to wit:

Parcel I. Beginning at an iron pin at the intersection of the eastern edge of Green Avenue and the southern edge of West Curtis Street (First Street), thence with the southern edge of said West Curtis Street, N. 65-05 E. 741.3 feet to an iron pin at the intersection of the southern edge of West Curtis Street with the western edge of South Avenue; thence with the western edge of South Avenue S. 4-13 W. 152.5 feet to a spike in the western edge of South Avenue; thence continuing with western edge of South Avenue S. 5-07 E. 376.1 feet to an iron pin; thence continuing with the western edge of South Avenue S. 7-07 E. 396.5 feet to an iron pin at the intersection of the western edge of South Avenue with the northern edge of Woodside Circle
