DRAINAGE EASEMENT AGREEMENT

THIS AGREEMENT made and entered into this 9th day of March, RENKHRKYX 1982, by and between WALTER S. GRIFFIN, FAUST NICHOLSON, and DAVID D. DOUGLAS and THE CITY OF TRAVELERS REST, SOUTH CAROLINA.

WITNESSETH:

WHEREAS, The City of Travelers Rest, South Carolina, is the owner of a road known as Saddleback Cove, located in the County of Greenville, State of South Carolina; and

WHEREAS, Walter S. Griffin, Faust Nicholson, and David D. Douglas are the owners of a tract of land fronting on Saddleback Cove, being shown on plat prepared by Jones Engineering Service dated March 15, 1973; and

WHEREAS, Walter S. Griffin, Faust Nicholson, and David D. Douglas wish to grant, bargain, sell and release unto The City of Travelers Rest, South Carolina, its successors and assigns, forever, an easement permitting The City of Travelers Rest, South Carolina, to cast surface water from Saddleback Cove over, upon, onto, and through the following described property owned by Walter S. Griffin, Faust Nicholson, and David D. Douglas:

ALL that certain piece, parcel or tract of land, situate, lying and being near the Town of Travelers Rest in Greenville County, South Carolina, containing 109.10 acres, being bounded by Howard Street, Old Buncombe Road, McElhaney Road, and lands of Martin, Rice, Evins, Watson, and others, and having, according to plat prepared by Jones Engineering Service dated March 15, 1973, the following metes and bounds, to-wit:
