## §C. Powers Relating to Custody of Person

- 1. In general, and in addition to all the specific act: in this section enumerated, to do any other act or acts, which I can \$0 through an agent, for the welfare of my spouse, children and/or dependents or for the preservation and maintenance of my other performal relationships to parents, relatives, friends and organizations;
- standard of living of my spouse, children and/or dependents of mink, including by way of illustration and not by way of restriction, provide living quarters by purchase, lease or by other contract, of by payment of the operating costs, including interest, amortization payments, repairs and taxes, of premises owned by me and occupied by an family and/or dependents, to provide normal domestic help for the operation of the household, to provide usual vacations and usual travel expenses, to provide usual educational facilities, and to provide: funds for all the current living costs of my spouse, children and/or dependents, including, among other things, shelter, clothing, four and incidentals; and if necessary to make all necessary arrangements, contractual or otherwise, for me at any hospital, nursing home, convalescent home or similar establishment;

To continue whatever provision has been made by me, Ariot to the creation of this power or thereafter, for my spouse, childled and/or dependents, with respect to automobiles, or other means of transportation, including by way of illustration but not by way of restriction, power to license, to insure and to replace any automobiles owned by me and customarily used by my spouse, children and/or dependents; to apply for a Certificate of Title upon, and endorse: And transfer title thereto, any automobile, truck, pickup, van, motor of that the title to said motor vehicle is free and clear of all lies and encumbrances except those specifically set forth in such transfer: assignment;
- 4. To continue whatever charge accounts have been operated by me prior to the creation of this power or thereafter, for the convenience of my spouse, children and/or dependents, to open such accounts as Attorney shall think to be desirable for the accomplicated of any of the purposes enumerated in this section, and to pay the freest charged on such accounts by any person authorized or permitted by the make such charges prior to the creation of this Power;
- 5. To continue the discharge of any services or dutiess assumed by me prior to the creation of this power or thereafter, (A AL) parent, relative or friend of mine;
- 6. To supervise, compromise, enforce, arbitrate, defend of settle any claim by or against me arising out of property damages Af personal injuries suffered by or caused by me, or under such circumstances that the loss resulting therefrom will, or may fall. An me; or to intervene in any action or proceeding relating thereto;
- 7. To continue payments incidental to my membership or affiliation in any church, club, society, order or other organizasion or to continue contributions thereto;
- 8. To demand, to receive, to obtain by action, proceeding or otherwise any money or other thing of value to which I am or may lacouse or may claim to be entitled as salary, wages, commission or other; distribution upon any stock, or as interest or principal upon any indebtedness, or any periodic distribution of profits from any partnership or business in which I have or claim an interest, and for endorse, collect or otherwise realize upon any instrument for the payment so received;
