ALL that piece, parcel or lot of land lying, being and situate in the Village of Fork Shoals, County and State aforesaid, known as Lot No. 31 on a plat of the subdivision entitled "The Residential Property of Fork Shoals, S.C. of Reigel Textile Corporation", made by Pickell & Pickell, dated February 1953 and recorded in the R.M.C.
