KNOW ALL MEN BY THESE PRESENTS, that We, Calista E. Causey as Attorney-in-Fact for Ottis R. Causey and Calista E. Causey, Individually

in consideration of \$1.00 and Love and Affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

DONALD M. CAUSEY, Jr. and RION ALAN CAUSEY, their heirs and assigns, THE percentage of ownership as set forth below:

ALL that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, containing 85 acres more or less as shown on plat of property of Ottis R. Causey and Calista E. Causey near Blyth Shoals in Greenville County according to a survey made by W. R. Williams, Jr., Engineer, August 30, 1982, and having according to said plat the following courses and distances, to wit:

BEGINNING at iron pin in the right of way of the Greenville City Water Works and running thence N. 7-57 W. 184.2 feet with South Saluda River as the line; thence continuing with the river as the line N. 7-07 E. 411.3 feet to a birch tree 30m; running thence along line of property now or formerly of Wilkinson N. 45-00 E. 1,188 feet to iron pin; thence continuing with the Wilkinson property S. 47-00 E. 2,178 feet to iron pin at the corner of property now or formerly of Brown; running thence S. 22-55 W. 1,642 feet to a point at South Saluda River; running thence with the river as the line N. 19-07 W. 225.9 feet to iron pin; thence continuing with the river as the line N. 42-08 W. 274.2 feet to iron pin; thence leaving the river as the line and running N. 39-44 W. 364.1 feet to a point in the right of way of the Greenville City Water Works; running thence through the right of way of Greenville City Water Works the following courses and distances; N. 55-42 W. 644.6 feet to iron pin; thence continuing N. 54-35 W. 963.8 feet to iron pin the beginning corner.
