the receipt of which is hereby acknowledged, he granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

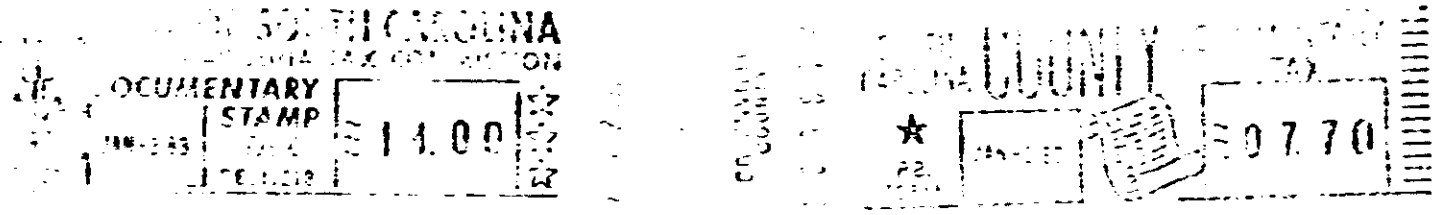
GARY B. TURNER & PATRICIA O. TURNER, their heirs and assigns forever;
