All that piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, on the southwestern side of Bethany Road, being shown and designated on a plat entitled "Survey for Benjamin C. Burton, Jr., Carol C. Burton" prepared by Freeland & Associates, dated November 18, 1982, and recorded in the RMC Office for Greenville County in Plat Book 9-H, at page 73, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point, said point being an iron pin, approximately 355.50 feet from Bethany Road and running S.2-24W., 278.04 feet to an iron pin; thence turning and running S.62-39W., 234.50 feet to an iron pin; thence turning and running N.0-37W., 208.00 feet to an iron pin; thence turning and running N.51-22E., 284.40 feet to an iron pin, the point of beginning; and containing approximately 1.18 acres, more or less.

ALSO: All that piece, parcel or strip of land situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, on the southwestern side of Bethany Road, adjacent to the above property, and being shown and designated as a 20 foot easement on the plat above referenced, and having, according to said plat, the following metes and bounds, to-wit:
