The debtor represents that he is an individual with regular income who owes, as of the date of the filing of this petition, noncontingent, liquidated, unsecured debts of less than \$100,000 and noncontingent, liquidated secured debts of less than \$350,000.

The debtor's plan is to pay from future income and earnings, as much as he reasonably can, as determined by the Court, for a period not less than 36 months and not in excess of 60 months. That the debtor considers the said reasonable amount to be \$200.00 dollars per month\*. However, the said sum is subject to the determination of the Court from time to time. The said funds will be disbursed to creditors, as may be approved by the Court, after first deducting costs of administration. Debtor has his principal place of employment, his residence or domicile or owns property, within this District. No bankruptcy case initiated on a petition by or against the debtor is now pending. Debtor hereby makes application for an additional twenty (20) days in which to file the remaining part of the Chapter 13 Statement and to pay the filing fee for this case in two (2) equal installments.

Annexed hereto are the following: Schedule A, which sets forth a complete statement of all his debts with the full names and addresses of all his creditors and Schedule B, which sets forth accurate descriptions and valuations of all the items of his property, real and personal. The remainder of the Chapter 13 Statement will be duly filed.

WHEREFORE, the debtor prays for relief under Chapter 13 of the Code.

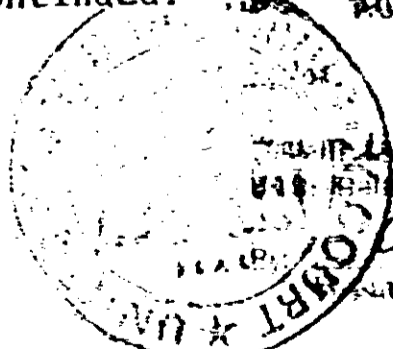
