ALL that certain piece, parcel or lot of land with the improvements thereon located near the City of Greenville, State of South Carolina, and being more fully described as follows:

Beginning at a point on the north side of Gilreath Street, on the eastern edge of Southern Railway right-of-way (which right-of-way extends 100 feet eastward from the center of Southern Railway tracts) and running thence along the extending edge of said right-of-way a distance of 387.4 feet to the southern side of Cox Street; thence running along Cox Street in an easterly direction for a distance of 222.2 feet to a stake; thence running along the property line of Dance Freight Lines, Inc., in a southerly direction for a distance of 297 feet to a stake on the northern side of Gilreath Street in a westerly direction for a distance of 176.5 feet, to the point of beginning.
