## **POWER OF ATTORNEY** AND REVOCATION OF PRIOR POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: that the undersigned Corporation hereby;

(ii) for it and in its name and stead to sell and assign to HOUSEHOLD BANK f.s.b., notes, security agreements and related documents (including real estate mortgages and trust deeds); provided that these presents are subject to the power of said Corporation, hereby expressly reserved, to revoke the same at any time.
