ERNEST B. HUDSON, a son of PERRY E. HUDSON and EVA L. HUDSON, died intestate on July 7, 1961, survived by his wife, MARY LOUISE BARNETT HUDSON, and their children, BRUCE F. HUDSON, GLEN W. HUDSON, and RAYMOND E. HUDSON. See Apartment 767, File 23, Probate Court for Greenville County, South Carolina.

BRUCE F. HUDSON conveyed his interest in a portion of the property to his brother, GLEN W. HUDSON, by deed dated July 7, 1964, recorded July 24, 1964 in the R.M.C. Office for Greenville County, South Carolina in Deeds Book 753, Page 509.

GLEN W. HUDSON conveyed to his mother, MARY LOUISE BARNETT HUDSON, his interest in the lot conveyed to him by BRUCE F. HUDSON in Deeds Book 753, Page 509 and his interest in the estate of his grandfather, PERRY E. HUDSON, by deed dated November 10, 1969, recorded November 13, 1969 in the R.M.C. Office for Greenville County, South Carolina in Deed Book 879, Page 313.

By deed dated July 26, 1983, recorded July 27, 1983 in said R.M.C. Office in Deeds Book 1193, Page 129, MARY LOUISE BARNETT HUDSON reconveyed to GLEN W. HUDSON all of the property and interest conveyed to her by the deed recorded in Deed Book 879, Page 313, less any property described therein which had been previously conveyed.

PERRY A. HUDSON, a son of PERRY E. HUDSON and EVA L. HUDSON, died intestate on May 30, 1974, survived by his wife, VENICE HUDSON (now VENICE HUDSON ROBERTSON), their children, DAVID A. HUDSON, LINDA JEAN HUDSON SMITH, CAROL HUDSON BOYER, and SANDRA HUDSON TRAMMELL, and the children of a predeceased son, RONALD C. HUDSON. See Apartment 1340, File 20, Probate Court for Greenville County, South Carolina.


RONALD C. HUDSON, a son of PERRY A. HUDSON and VENICE HUDSON, (now VENICE HUDSON ROBERTSON), died intestate on September 3, 1966, survived by his wife, SARAH LOUISE SMITH HUDSON, and their children, CLIFTON A. Office for Greenville County, South Carolina in Deed Book 579, Page 249. ERNEST B. HUDSON, referred to above, was a son of PERRY E. HUDSON and EVA L. HUDSON.

By deed dated August 11, 1983, recorded September 6, 1983, in said R.M.C. Office in Deeds Book 1195, Page 834, CLIFTON A. HUDSON, SEBRINA KAYE HUDSON (now SEBRINA KAYE HUDSON RIEDEL), and ROBIN LORRAINE HUDSON (now ROBIN LORRAINE HUDSON ALDRICH) conveyed to their grandmother, VENICE HUDSON ROBERTSON their interest in the property described in this deed, which is a portion of the remaining property of the Estate of Perry E. Hudson.
