Douglas Hudson and Mescal Hudson, their heirs and assigns forever:

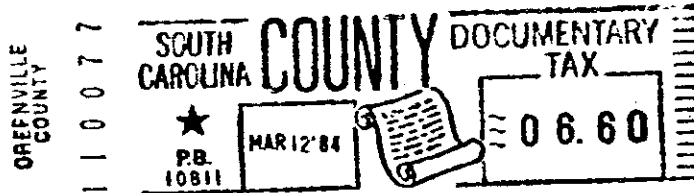
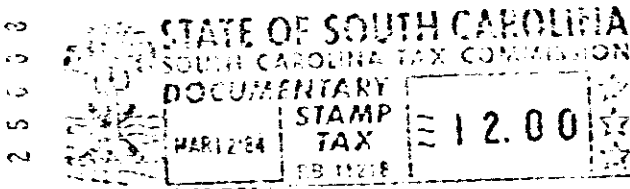
