GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, Clarice Dill McGill, of Greenville County, S. C., have made, constituted and appointed, and by these presents do make, constitute and appoint William Heek McGill, of Union County, S. C., my true and lawful attorney-in-fact for me and in my name, place and stead to demand, receive, collect and hold any and all monies, securities, personal and real property of any nature whatsoever in which I may have any interest to carry bank accounts for me and in my name in such banks as he may deem best, and to make deposits and disbursements therein and therefrom concerning my best interest and considering my comfort, support, maintenance and medical attention as in his judgment is best; further, to make disbursements of funds belonging to me in such manner, at such times and for such purposes as he may, in his judgment, deem best for maintenance, upkeep, repair or any other purposes in connection with any real estate or personal property owned by me; to sell, manage, control, invest and reinvest any real estate, stocks, bonds or other types of property that I may own, and to exercise general control over same; to vote all stocks and collect dividends, profits or accruals therefrom, and sell, invest and reinvest and completely manage and control all types of investments as he determines best; to sue for me and in my name for whatever he believes I am entitled to receive; to borrow as he deems advisable, and to pledge or mortgage my property, real or personal, as security for any such loans; to defend any legal action against me in my name; to make and verify income tax returns, claims for refund, requests for extensions of time, etc. in my name; to sign any and all papers, deeds, stock certificates or other instruments necessary to carry out any of the aforementioned powers, hereby granting full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully to all intents and purposes as I might or could do if personally present and competent.

This Power of Attorney shall not be affected by physical disability or mental incompetence of Clarice Dill McGill, the Principal herein, which renders the said Clarice Dill McGill incapable in or of managing her own estate and affairs. My specific intent is that the authority granted in this Power of Attorney shall be exercisable by said attorney notwithstanding any physical disability or mental incompetence sustained and/or suffered by me.

No inventory or account shall be filed with any Court or the Clerk thereof, but an accounting shall be filed with the undersigned each year, and with the undersigned's executor in the year of my death.

And I do hereby ratify and confirm all things so done within the scope of the authority herein given him as fully and to the same extent as if by me personally done so long as done by William Heek McGill.
