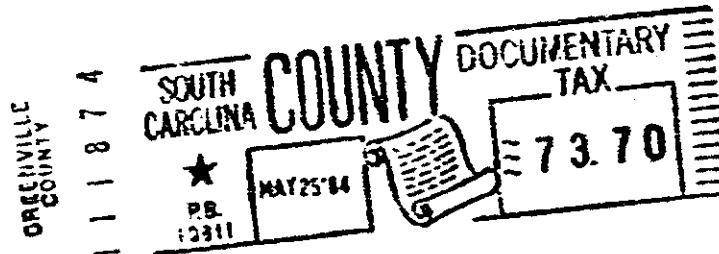
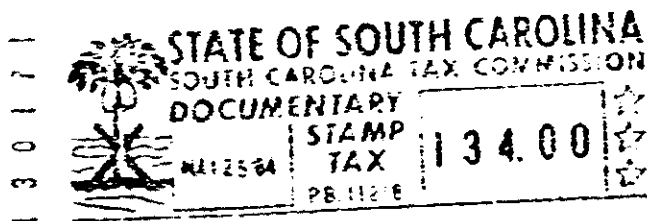
In consideration of Sixty Seven Thousand (\$67,000.00) ----- Dollars,
