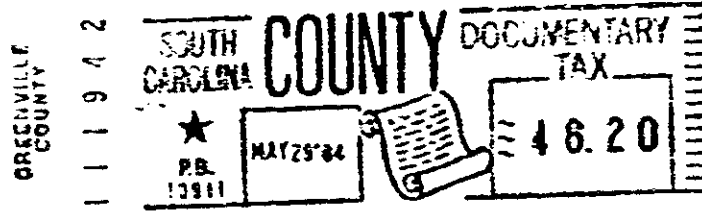
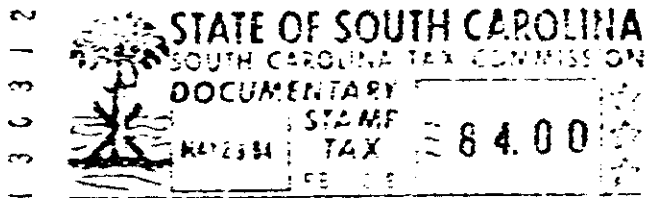
in consideration of Forty-Two Thousand and No/100 (\$42,000.00) Dollars,
