BEGINNING at an iron pin on the northern side of Oakwood Avenue, joint front corner of Lots 32 and 31 and running thence N. 35-38 W. 160 feet to an iron pin; thence S. 54-44 W. 40 feet to an iron pin; thence S. 45-34 W. 136.3 feet to an iron pin on the northern side of Holly Knoll Drive; thence along Holly Knoll Drive, S. 70-32 E. 148.0 feet to an iron pin in the intersection of Holly Knoll Drive and Oakwood Avenue, thence following the curvature of said intersection, the chord being N. 81-51 E. 51.9 feet to an iron pin on the northern side of Oakwood Avenue; thence along the northern side of Oakwood Avenue, N. 54-22 E. 34.9 feet to the beginning corner; being the same conveyed to us by First Federal Savings and Loan Association of Greenville by deed dated March 30, 1966, and recorded in the R.M.C.
