This power of attorney shall remain in full force and effect until revoked by me by endorsement upon the original hereof and, if the original shall at any time be recorded in the Office of the Clerk of Court or the Office of the Register of Mesne Conveyance in any county of any state, then by a record of such revocation upon the face of the record of this instrument in the said Office of the Clerk of Court or the Office of the Register of Mesne Conveyance of the county where said instrument is recorded.

This Power of Attorney shall not be affected by physical disability or mental incompetence of the principal which renders the principal incapable of managing his own estate.
