BEGINNING at an iron pin in the center of Stewart Road (said iron pin lying 914 feet, more or less, from intersection with Bethany Road), joint corner with property now or formerly of Grantor, and running thence N. 13-46 W., 263.8 feet to an iron pin; thence turning and running N. 76-24 E., 252.0 feet to an iron pin; thence turning and running S. 13-46 E., 263.8 feet to an iron pin in the center of Stewart Road; thence turning and running along center of said road S. 76-24 W., 72 feet to a nail and cap; thence turning and running N. 13-46 W., 213.8 feet to an iron pin; thence turning and running S. 76-24 W., 150.0 feet to an iron pin; thence turning and running S. 13-46 E., 213.8 feet to a nail and cap in the center of Stewart Road; thence turning and running along the center of said road S. 76-24 W., 30 feet to an iron pin at the point of beginning.
