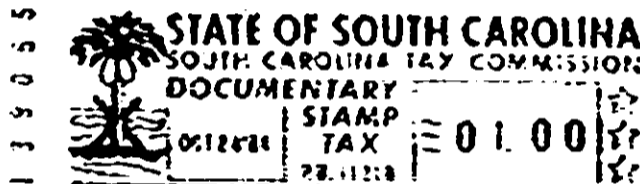
Robert M. Morgan and William L. Morgan, their heirs and assigns forever:
