Both bargained and sold, and by these presents Both bargain and sell, unto the said John Bowie all that plantation or Tract of Land containing Four hundred and forty acres lying and being in Greenville County in Ninety six District on branches of the Golden Grove Creek a branch of Saludy River, bounding to the Southwest on land surveyed for Francis Gottier and all other sides on vacant land, Together with all and singular the Houses, ^{outhouses} edifices buildings barns Stables yards gardens Orchards Woods, underwoods Timber and Timber trees Pastures, ponds, lakes, fishings ways, waters, watercourses, paths, passages, liberties, privileges, fees, profits, hereditaments, rights, members, and appurtenances whatsoever, thereunto belonging or in any wise appertaining, and the reversion or reversions, remainder and remainders rents Issues and profits thereof, and of every part and parcel thereof To have and to hold the said plantation or tract of land containing four hundred and forty acres of land, with every the premises and appurtenances thereunto belonging, unto the said John Bowie, his heirs, Executors, administrators and assigns from the day next before the day of the date of these presents, for and during and unto the full end and Term of one whole year from thence next ensuing, and fully to be completed and ended yielding and paying therefore, unto the said Nathaniel Weed the rent of one pecker corn on the last day of the said Term, if the same shall be lawfully demanded to the intent and purpose that by virtue of these presents, and by force of the Statute for transferring of uses into possession the the said John Bowie may be in the actual possession of all and singular the premises above mentioned, with every the appurtenances thereunto belonging, and thereby be the better enabled to have take and receive the reversion and Inheritance thereof which is intended to be to him and his heirs granted and released by the said Nathaniel Weed by another Indenture intended to be made and dated the day next after the day of the date hereof.
