This Indenture made this thirtieth day of December in the Year of our Lord One
 thousand seven hundred and Eighty eight, and in the thirteenth year of the States Inde-
 pendence, Between William Henderson of Greenville County and State of South Carolina
 of the one part, and James Alexander of Spartanburgh County and State aforesaid
 the other part, Witnesseth that the said William Henderson for and in Consideration
 of the sum of five Shillings Sterling to him in hand well and truly paid to be paid by the
 said James Alexander at or before the sealing and delivering of these presents the receipt
