The following deed of Conveyance from Michael Miller to William Anderson was produced in Open Court November Term 1790 & Proven before Robert Wilson Esq<sup>r</sup> by the oath of John Clayton and ordered to be Recorded  
Recorded this 10th day of December 1790

This Indenture made this Twenty ninth day of September in the year of our Lord one thousand Seven hundred and Ninety fourth year of American Independance Between Michael Miller of the State of South Carolina & district of ninety six & Spartanburgh County of the one part & William Anderson of the district aforesaid & Greenville County of the other part. whereas in and by a certain Grant bearing date the Twenty first day of January Anno Domini one thousand Seven hundred & eighty five in the ninth year of American Independency from under the hand of his Excellency Benjamin Gurard Esq<sup>r</sup> Governor for the time being & the Great Seal of this State for that purpose appointed did Give and Grant unto Michael Miller a certain Tract of Land containing three hundred and eighty eight acres be the same more or less lying & being on both sides of middle Tigar River above the old boundary line all sides vacant Land when Surveyed & hath such shapes forms & marks as appears by a plat to said Grant annexed the s<sup>d</sup> plat & Grant bearing date being duly Recorded in the Secretaries Office & the s<sup>d</sup> Land conveyed from the s<sup>d</sup> Michael Miller to William Anderson by a deed bearing date the Twenty ninth day of September one thousand Seven hundred and ninety. Witnesseth that the s<sup>d</sup> Michael Miller for the consideration of the sum of one hundred pounds Sterling Money to him the s<sup>d</sup> Michael Miller in hand well and Truly paid the sum of which he has hereby acknowledged he the s<sup>d</sup> Michael Miller hath Granted bargained & Sold & by these presents doth Grant bargain & Sell
