The following Deed of conveyance from David Henderson to Abednego Chandler being proven before William Stevenson Esq^r by the oath of Charles Littleton was presented and Recorded this 8th day of January 1796 State of South Carolina Ninety six District This Indenture made the sixth day of August in the year of our Lord one thousand seven hundred and ninety three and in the 18th year of American Independence between David Henderson of Newbury County State of South Carolina of the one part, and Abednego Chandler of Greenville County and State aforesaid of the other part witnesseth that the s^d. David Henderson for and in consideration of the sum of fifty pounds Sterling money to him in hand paid or secured to be paid by the s^d. Abednego Chandler hath bargained and sold and by these presents doth bargain & sell make over and confirm unto the said Abednego Chandler his heirs Exec^t. Adm^t. & assigns for ever one certain tract or parcel of land containing one hundred and sixty two acres situate on Gilders Creek on the waters of Enoree River its courses or boundaries as follows Viz Beginning on the East at a pine thence S 50 W to a post oak then
