andor being proven before James Kellogg Esq^r by the oath of William
Collins was presented & recorded this 9th day of April A.D. 379 8

This Indenture made this ninth day of January in the year of
our Lord one thousand seven hundred and ninety two, and in the inde-
pendence of the United States of America the twentieth between James
Wofford of the State of South Carolina Spartanburgh County of the one
part, & Joseph Alexander of the State aforesaid Greenville County of the
other part witnesseth whereas it is and by certain Grant of two hundred
and two acres of Land granted to James Wofford bearing date the fourth
day of July 1791 situate lying on the branches of Rayburns Creek, waters
of Reedy River running S.W. & S.E. by John Howard's land, & N.W. & N.E. by
Henderson's S.E. by Samuel Cobb & N.E. & N.W. by Collins land the other
sides by vacant Land, and hath such shape & Marks as by affidavit to the
said grant annexed, now this Indenture witnesseth that the said
James Wofford for and in consideration of the sum of twenty pounds
Sterling to him in hand paid by the said Joseph Alexander the re-
ceipt whereof is hereby acknowledged, that he the said James Wofford
is well contented, satisfied and paid, hath granted, bargained, ~~for sold~~ ⁱⁿ
by these presents doth grant, bargain & sell, remise, release & convey unto
the said Joseph Alexander his heirs and assigns two hundred & two acres
of Land as aforesaid together with all and singular the houses, building
gardens, orchards, trees, wood, water & water courses, hereditaments and
appurtenances, as also the reversions, rents, issues & profits of two hundred
& two acres of Land as aforesaid with every the premises & appurtenances
thereunto belonging to the only proper & absolute use & behoof of him the
said Joseph Alexander his heirs and assigns the the s^r Joseph Alexan-
der his heirs Exec. Adm^r or assigns shall and may from time to time &
at all times hereafter have hold use occupy possess and enjoy the said
plantation or tract of two hundred & two acres of Land as aforesaid without
any manner of trouble hindrance & molestation interruption or denial
of him the said James Wofford his heirs Exec. Adm^r or assigns or any
other person or persons but shall and will warrant and for ever defend
the said tract of two hundred and two acres of Land as above mentioned In
