 presented and recorded this 9th day of June A 1796 261
 State of Carolina, Know all men by these presents that I Aaron Kemp
 of Greenville County in the State afores^d for and in consideration of the
 sum of fifty pounds to me in hand paid by Alsey Kemp of the same County
 and State afores^d have granted bargained sold & released & by these presents
 do grant bargain sell & Release unto the said Alsey Kemp all that tract of land
 containing one hundred acres more or less lying on Brushy creek of Enore
 river, the one beginning on post oak corner and running S. 60 E 31. 62 to a stump
 thence N 25 E 30 to a red oak corner, thence N 50 W 20 to a post oak, thence N 10 E 11 to a
 stake corner, thence to the beginning it being part of a Tract of Land containing
 one hundred and seventy acres granted unto Aaron Kemp & Robert Seago from
 under the hand of their Excellency Charles Pinckney bearing date the 4th April one
 thousand seven hundred & ninety two recorded in secretaries Office grant Book
 D. N. 5. page 530, and the other beginning at Brushy Creek, running N 30 E to
 a post oak corner thence S 60 E to brushy creek thence up creek to the beginning
 it being part of a Tract of Land containing one hundred acres granted unto
 Paul Abner from under the hand of his Excellency Benjamin Guard bear-
 ing date the twenty first day January one thousand seven hundred and
 eighty five recorded in secretaries Office grant Book A. N. A. page 708 he
 the said Aaron Kemp hath granted bargained and sold & released the above
 described Tracts of Land containing one hundred acres together with all and
 singular the rights members hereditaments and appurtenances to the said
 premises belonging or in any wise Incident or appertaining to have and to
 hold all and singular the premises before mentioned unto the s^d Alsey Kemp
 his heirs and assigns for ever and I do hereby bind myself my heirs &c^t
 and Adm^t to warrant and for ever defend all and singular the premises
 unto the said Alsey Kemp his heirs and assigns against myself and my
 heirs and against every person whomsoever lawfully claiming or to claim
 the same or any part thereof witness my hand & seal this in the year
 of our Lord one thousand seven hundred and ninety six and in the
 twenty first year of the Independence of the United States of America
