The following Deed of Conveyance from Thomas Sinkens to John Alexander
 being proven before Humphrey Cobb Esq^r by the oath of James Cooper was
 presented and Recorded this 19th day of April 1797.
 This Indenture made this sixteenth day of April one thousand seven
 hundred and ninety four between Thomas Sinkens of South Carolina and
 Greenville County of the one part & John Alexander of the said State & County
 of the other part witnesseth that the said Thomas Sinkens for and in con=
 sideration of the sum of four pounds 10^s lawful Sterling money to him in
 hand well and truly paid at and before the sealing and delivery of these pre=
 sents the receipt whereof is hereby fully acknowledged hath bargained sold
 aliened released and confirmed and by these presents doth bargain sell alien release
 and confirm unto the said John Alexander all that part of a certain tract
 of land which was granted unto Mirjah Sinkens for six hundred and forty acres
 lying in Greenville County on the waters of Reedy River and signed by his Excell=
 ency Governor Moultrie on the 5th June 1786 all that part of said Tract of land
 beginning at a post oak the lower corner of the Original Tract from thence N 44 25
 on the said line thirty five chain to a Hickory corner from thence S 44 50
 to a post oak the lower corner of the Original line from thence on the Original line S E
