The following deed of Conveyance from Edward Howard to John Parish being proven before James Ridgou Esq. by the oath of Samuel Howard was presented and Recorded this 8<sup>th</sup> Sept. 1797  
 This Indenture made this third day of February 1797 between Edward Howard of the State of South Carolina Greenville County of the one part, & John Parish of the County & State aforesaid of the other part witnesseth that the said Edward Howard for and in consideration of the sum of fifty pounds lawful money to him in hand paid the receipt whereof is hereby acknowledged hath bargained and sold and by these presents doth bargain alien sell release and confirm unto John Parish for ever all that plantation or Tract of land containing one hundred and ninety six acres it being apart of a Tract 265 acres Originally granted to said Thomas Jones by patent bearing date the fourth day of July 1791 and Recorded in Grant Book C page 462 N. 5 Situate in Greenville County State aforesaid on both sides of the N Fork of Rayburns Creek the land to be conveyed begins as follows (Viz) beginning at a stake 3+ om for said Tract & runs S 80 W 8 7/5 to a white oak 3+ nm on Stephen Marchbanks land, thence on said Marchbanks line due South 27 chains to a stake 3+ om, thence due West on said Tract 27 ch to a red oak 3+ nm on s. Jones line, again thence on said line S 10 E 53-50 to a post oak 3+ om, thence S 50 E 9 ch to a post oak 3+ om, thence N 70 E 35 ch to a stake 3+ om, thence N 10 W 19 ch to Stake 3+ om, thence N 70 W 23 ch to a pine 3+ om, thence N 20 E 25 to Red oak 3+ om, thence N 10 W 33 chains to the beginning Stake Corner, which Includes the full quantity of land to be conveyed, & the said Edward Howard doth covenant and agree to and with the said John Parish that he will for ever warrant and defend the above described one hundred and ninety six acres of land from himself his heirs Exors. Admrs. or assigns or any other person or persons whatsoever laying any Just or lawful right title or claim thereunto, or any part thereof Together with all and singular the appurtenances hereditaments Emoluments commodities rents Issues & profits thereunto belonging or in any wise appertaining thereunto but to the only proper use and behoof of him the said John Parish he his heirs
