426 The following deed of Conveyance from Denis Duff to Thomas Ellidge being proven before Robert Cook Esq<sup>r</sup> by the oath of John Laws was presented and Recorded this 8<sup>th</sup> day of September 1797

This Indenture made this sixteenth day of January one thousand seven hundred and ninety seven between Denis Duff on the one part and Thomas Ellidge on the other both of the State of South Carolina & Greenville County witnesseth that the said Denis Duff for and in consideration of the sum of twelve pounds Sterling to him in paid by the said Thomas Ellidge at or before the ensaing and delivering of these presents the receipt and payment whereof is hereby fully acknowledged hath given granted and sold, and by these presents doth give grant bargain and sell aline and release convey and confirm unto the said Thomas Ellidge and to his heirs and assigns for ever a certain piece tract or parcel of land situate lying and being in the afores<sup>t</sup> State & County being part of a tract of land laid off to Denis Duff and granted 4<sup>th</sup> J<sup>l</sup> of June 1786 having such shapes marks bolls and bounding as were agreed on between the s<sup>r</sup> Denis Duff & Thomas Ellidge bounding as follows, Viz, begining on a forked white oak to a forked Dogwood, thence to a crooked Hickory, thence to a Black oak, then white oak by a dogwood together thence to the begining forked white oak containing by estimation a half an acre <sup>or</sup> ~~the same more or less being part of the tract~~ wherein the said Denis Duff now lives and stand together with all ways and waters water courses and appurtenances whatsoever unto the same belonging or in any wise appertaining and all the profits advantages thereunto belonging free and payable to enjoy & possess the same for ever to and the said Denis Duff his heirs Adm<sup>t</sup> and every of them shall and will warrant & by these presents for ever defend to the above named Thomas Ellidge his heirs & assigns against all and every person or persons lawfully claiming the said tract or any part thereof in witness whereof the said Denis Duff hath set his hand & affixed his seal the day and year first above written Signed Sealed & Delivered in presence of
