The following deed of Conveyance from John Mahaffey to Reuben Smith Jun^r being proven before James Kilgour Esq^r by the oath of John Kitcher was presented and recorded this 9th day of September 1797

This Indenture made this twentieth day of January one thousand seven hundred and ninety seven between John Mahaffey of the state of South Carolina Greenville County of the one part and Reuben Smith Jun^r of the State and County aforesaid of the other part witnesseth that the said John Mahaffey for and in consideration of the sum of forty five pounds lawful money to him in hand paid the receipt whereof is hereby acknowledged hath bargained and by these presents doth bargain sell alien release and confirm unto Reuben Smith Jun^r all that Tract or plantation of land situate in the State and County aforesaid on the Southside of Rocky creek waters of Enoree river, and on some branches of said creek it being apart of a Tract of five hundred acres granted to the said John Mahaffey by Patent bearing date the seventh day of January 1795 & recorded in grant book B N^o 5 page 159 the quantity of land to be conveyed is three hundred and forty three acres beginning at a forked chestnut corner on for said Tract and runs on Sanders line 160 & 58 chains to a post oak 3+0m, thence S 57 E 37 chain to a post oak 3+0m thence N 5 W 19 ch to a pine 3+0m, thence N 40 W 36.50 to a red oak 3+0m, thence N 78 W 14.00 to a red oak 3+0m, thence S 61 W 5.50 to a spanish oak, thence N 59 W 30 ch to a red oak 3+0m, thence S 67 W 36 ch to a pine 3+0m, thence S 15 E 32 & 50 links to a red oak 3+0m, thence N 9 E 21.75 to the beginning forked chestnut corner which includes three hundred & forty three acres of land and (further) the said John Mahaffey doth covenant and agree to and with the said Reuben Smith Jun^r the above mentioned and described three hundred and forty three acres of land is free and clear from any manner of Incumbrance whatsoever & that he the said John Mahaffey will for ever warrant and defend the same together with all and singular the appurtenances hereditaments and ornaments rents Issues and profits thereunto belong or in any wise appertaining thereunto or any part thereof from himself his heirs Executors Administrators or assigns or any other person or persons whatsoever laying any Just or lawful right title or claim thereunto or any part thereof but to the only proper use and behoof of him the said Reuben Smith Jun^r his heirs Executors Administrators or assigns for ever In witness whereof the said John Mahaffey hath hereunto set his hand & affixed his seal the day and date first above written John Mahaffey
