County & State on the Middle fork of Marsh Creek containing One hundred acres, be the same more or less, & bounded by Conditionally lines agreed between John Lucas & S<sup>c</sup>. Rich<sup>d</sup>. Forrest, beginning on the S<sup>c</sup>. Forrest's line on Tea Oak corner running thence to Maple on Brasdy line, thence along S<sup>c</sup>. line to Calloway's Line thence to Prinell's line, thence to the afores<sup>d</sup> forest line thence to the beginning - being part of a tract of Land granted to John Nicholl by his Excellency Chas. Pinckney Esq<sup>r</sup>. 1787.
