Together with all and Singulare the Rights, members, hereditaments, & appurtenances. To have and to hold all and singular the premises before mentioned unto the S^r David Cotton his heirs and assigns forever. and I do hereby bind my self my heirs executors and Adm^rs^r to warrant and for ever defend all & singular the said one hundred acres of land with the premises unto the S^r David Cotton his heirs and assigns against myself my heirs & assigns & all and every other person or persons whatsoever. in witness whereof I do hereunto set my hand and seal this first day of October one thousand eight hundred and One — Signed Sealed and delivered in presence of us James Cotton. Hazleah ^{his} Cockrum — James ^{his} Dyal ^{Seal}

This Deed made this 14th day of January 1802. between John Butler of the State of S^r Carolina and District of Greenville of the one part, & Horatio Griffin and Esq^r of the County & State aforesaid witnesseth that the said John Butler for and in consideration of the sum 23 dollars and 98 Cents to me in hand paid by the said Horatio Griffin ^{Esq^r} before the Sealing & delivering of these presents the R^t which is hereby acknowledged by the S^r John Butler hath granted bargained and sold, and by these presents doth Grant bargain Seal and Release & Confirm unto the said Horatio Griffin & C^r their Heirs and assigns forever, all that Tract of land that said John Butler now has or bounded by John Dacus land Drury Drayrys Land & Thos. Butler land & Willis Butlers land, Containing One hundred acres more or less. together with all and singular the appurtenances heretofore belonging or in any wise appertaining, together with all the Rights titles interest claim or demand of in & to every part thereof to have and to hold the said tract of land together, with all & singular the premises hereby granted bargained & sold or intended to be granted bargained & sold to the said Griffin & C^r their Heirs & assigns to the only purpose and intent of the S^r Horatio Griffin & C^r their heirs & assigns forever.
