 Demands whatsoever of him the said Angus McAllister of in and to, Together the
 Tracts of lands and Premises above mentioned and every Part and Parcel thereof to
 the only use and behoof of him the said John Stanford forever: and the said Angus
 McAllister for himself and his heirs and against every of them unto the said John
 Stanford his heirs and assigns, shall and will warrant from all other Persons Lawful-

 Spanish oak on the north bank of said Fork thence North twenty Eight degrees West to a white
 oak on the orchard branch thence down the said Branch to Biddens line thence
 Suddline to Sherrills line thence Sherrills line to Easter Thomas's State corner thence
 South Eight degrees west fifty chain to the Beginning: Together with all singular
