


The third containing sixty two acres, Being part of a Tract of land originally granted to John Foster and conveyed by Kittis down to Overton Goodman, and from him to Harden Camp which in all contains two hundred and Eighty Six acres as the plat and Deeds thereof Represents Together with all and singular the rights members Hereditaments, & appurtenancy to the said premises belonging or in any wise appertaining - To have and To hold all and singular the premises before mentioned unto the said William Tinsley his heirs and assigns forever. and I do hereby bind myself my heirs Executors &c, to warrant and forever defend, all and singular the Premises before mentioned unto the said William Tinsley his heirs and assigns against myself my heirs, & against every other Person or Persons Lawfully claiming or to claim the same or any part thereof -



W. 20. Ch<sup>o</sup>. 50. to a stake thence S. 52. E. 40. to a Spanish Oak thence N. 40. E. 49 to a stake thence N. 75. W. 40. Ch<sup>o</sup>. to a red oak thence S. 80 to a stump, in the road, thence S. 43. E. 15. Ch<sup>o</sup>. to the Beginning. Including one hundred and thirty six acres more or less, it being part of a tract of land granted Originally to Mr Safferty - Together with all that appertains therunto To Have and To hold all and singular the premises to the s<sup>t</sup> Simbright Robins his heirs & assigns forever - and I the said James Ride do bind myself my heirs Executors and administrators to warrant and forever defend the above bound land and premises unto the said Simbright Robins his heirs and assigns against myself my heirs and assigns and against every other person claiming or to claim the same or any part thereof -
