

Know all men by these presents that I Cyprian Farrar of the City of Natchez in the Mississippi Territory, Have made ordained authorized constituted and appointed and by these presents do make ordain authorize constitute and appoint Thomas Farrars of Pendleton District in the State of South Carolina, my true and Lawfull attorney for me and in my name, to Grant bargain and sell, all that tract or parcel of Land Situate Lying and being in the State aforesaid, on a certain creek commonly called Bufokry Creek, being all that tract of land conveyed to me by Ben. Gurard Esq. And also, all my estate right title, and Interest, in and to the said Premises and every part and Parcel thereof, unto Moses Kemp of Greenville District in the State aforesaid his heirs and assigns forever, and also for me, and in my name place and Stead and as my proper act and deed to Execute Seal and Deliver such Conveyances and Assurances of the said Premises unto the said Moses Kemp his heirs and assigns to the only Proper use and behoof of him the said Moses Kemp his heirs and assigns forever, as shall be needfull and requisite for the doing thereof, Giving and by these presents Granting unto my said attorney full power and absolute authority to do, Execute and perform any act or acts thing or things whatsoever that shall be needfull and necessary to be done touching or concerning in any wise the premises or the conveying, or assuring thereof to the Person & uses aforesaid in as full and ample a manner, to all intents and purposes as I the said Cyprian Farrar, might or could do, if personally present, Herby ratifying allowing and Confirming all and whatsoever, my said attorney shall do or cause to be done, by Write and according to the true intent and meaning of these presents
