Moore of Greenville District in the State of a certain Carpenter, for and in consideration
of the sum of Two hundred Dollars to me in hand paid by John Hassell of the same
place, Waggonmaker, Have granted bargained sold and Released and by these presents
do Grant bargain sell and release unto the said John Hassell, all that tract or parcel
of land Situate lying and being in the district aforesaid, on the waters of Reddy River
being the same land which I purchased of Joshua Hawkins, Beginning at an old
pine stump on J. Salmons line, thence Southwardly a conditional to a post oak
marked by the parties on the original line, thence along said line west to a Hickory
Corner, thence the original line north to a red oak corner, thence East to the Begin-
-ing, containing by estimation one hundred and eighteen acres be the same more
or less, Together with all and singular the rights members hereditaments, & appurtenances
to the said premises belonging or in any wise incident or appertaining — To Have &
To hold, all and singular the premises before mentioned unto the said John W. Hassell
his heirs and assigns forever, And I do hereby bind myself my heirs Executors and
administrators to warrant and forever defend all and singular the said prem-
-ises unto the said John W. Hassell his heirs and assigns against myself or my heirs
and against every other person or persons whomsoever lawfully claiming or to claim
the same or any part thereof — Witness my hand and seal this seventh day of
