



The State of South Carolina - Know all men by these Presents that I John Stokes of Greenville District, in the State aforesaid, for and in Consideration of the sum of four Hundred and fifty Dollars, to me in hand paid by Levi Stokes of the same Place, Have granted bargained sold and released and by these presents do grant bargain sell and Release unto the said Levi Stokes all that Plantation tract or Parcel of land, containing one hundred and five acres, be the same more or less situate lying and being in the District aforesaid on Reedy River, beginning on a Stake corner near the said river, on the original line thence with said line S: 60. W: 43 Chains to a red oak the original corner, thence with the original line S: 30. E: 31. Ch: 50 links to a stake corner, thence N: 62. E: 25. Chains to a black gum corner on the s^d River thence up the various meanders of the river to the beginning - bounded by a line running S.W. by Elisha Greensland. S.E. by Col. Alstons and N: E. by Reedy River being part of a tract of 640 acres of land originally granted to William Brandon, by grant bearing date 15th October 1784. and by said Brandon Conveyed to Jeremiah Stokes 23rd Dec: 1788. and this part Conveyed from said Jeremiah Stokes to John Stokes 13th of Sept: 1804 - Together with all and singular the rights, members, hereditaments & appurtenances to the said Premises belonging or in any wise incident or appertaining - To Have and To Hold all and singular the Premises before mentioned unto the said Levi Stokes his heirs and assigns forever, and I do hereby bind myself my heirs Executors and administrators to warrant and forever Defend. all and singular the said Premises unto the said Levi Stokes his heirs and assigns against myself and my heirs and against every other Person or Persons whomsoever Lawfully claiming or to claim the same or any part thereof - Witness my hand and seal this fourteenth day of January in the year of our lord one thousand Eight hundred & down and in the 31st year of American Independence - Signed Sealed and Delivered in presence of
