This Indenture made the 9<sup>th</sup> day of December one thousand Eight hundred <sup>513</sup>  
 and six Between William Anderson Sheriff of Greenville District and State of South  
 Carolina of the one part, and William Chandler, Planter, of the State and District  
 aforesaid of the other Part, Witnesseth, that William Horton is seized in fee simple  
 to him and his heirs forever, to a certain Parcel or tract of land Containing 360  
 acres three hundred and sixty acres situated in the District aforesaid bound  
 -ed on the East by Robert M. Deers land on the W. by said William Chandler  
 land, and on the N. & North E. by lands belonging to Anthony Griffin and Martin  
 Ayres, and whereas said William Horton did in Pindleton Court enter an action of debt  
 against Anthony Griffin in which action such proceedings were had that at March  
 Term one thousand Eight hundred and six, s<sup>d</sup> Horton got Cost & Costs was awarded  
 against him and from said Court there issued an Execution against said Horton  
 for the sum of sixty one Dollars & 34 Cents Directed to all and singular the Sher-  
 -iffs of said State Commanding each or either of them that of the goods & chattels  
 lands and other hereditaments belong to said Horton they make or cause to be made  
 the aforesaid sum of sixty one Dollars & 34 Cents & in obedience to said Writ said  
 taken into Execution all the aforesaid parcel of land & after giving notice of Exposing  
 the same for sale by advertisement and otherwise said on the first Monday in Sep-  
 -tember last at Greenville Courthouse sell the aforesaid land to William Chandler  
 for the aforesaid sum he at that Price being the last and highest bidder according  
 to Custom of such Vendees - Now this Indenture Witnesseth that that the said  
 William Anderson for and in consideration of the aforesaid sum to him in hand  
 pd<sup>d</sup> by the said Chandler at or before the sealing and Delivering of these presents  
 the receipt whereof is acknowledged doth granted bargain and sell unto the said  
 William Chandler all the aforesaid parcel or tract of land - Together with  
 all and singular the rights members and appurtenances whatsoever to said land  
 belong or in any wise Incident or appertaining the Reversion & Reversions remainder & Remainder  
 Rents Issues and profits thereof - and every part and parcel thereof unto the said William  
 Chandler his heirs and assigns to his and theirs Proper use & behoof forever -
