Grant bargain and sell unto Josiah Thompson of the District and State aforesaid
all that tract of land and Mills situate lying and being on Reedy River in the
District aforesaid, Containing by Estimation one hundred acres be the same more
or less. Beginning on a persimmon running an East Course to a postoak. South 30. E.
The east of said River, cornering on, on a black oak north Sixty to the west etc.
Chain 72. links cornering to a Stake thence N. 30. to the East to said River
thence down said River to the Beginning. Together with all and singular the right,
Members Hereditaments and appurtenances therunto belonging or in wise appur-
tenancing. To have and to hold, all and singular the Premises before mentioned to
the said Josiah Thompson his heirs and assigns forever - and I do hereby bind myself
my Heirs Executors and Administrators to warrant and forever defend, all and sin-
gulars the said Premises unto the said Josiah Thompson his heirs and assigns
against me & my heirs, and against the claim of all and every Person or Persons whom so ever
