 Recorded in the office of Greenvilles Register on a Stake near where it is called Barn  
 -hills old place running thence N. 66. W. 21 Chain to a pine corner of the original Survey  
 thence S. 25. W. 52 ch. to a black oak thence N. 88. W. 28 Ch. 50 links to a chestnut thence  
 N. 9. E. 29 ch. 50 links to a black oak, thence N. 8 ch. 50 links to a post oak, thence S. 24 ch.  
 to a Black, thence S. 28. W. 35 Ch. 50 links to Post Oak thence S. 75. E. 40 ch. 70 links to a post  
 oak thence N. 44. E. 38. ch. to a black oak dead & down, From thence to the Beginning -  
 Containing four hundred & seventeen acres more or less, To Have & To Hold all and  
 singular the premises before mentioned unto the said William Mason his heirs or  
 assigns forever, and I do hereby bind myself my heirs Executors & administrators
